Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 ¹ / ₄ " annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a current NOA.		
Fire Barrier Board:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing fo fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.		
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with the current published installation instructions and details in Gulf Coast Supply Rollformer Association's Installation Manual.		
Metal Panels and Accessories:	Install the "Versaloc 1.5 Aluminum Panel" including flashing penetrations, valleys, end lap and accessories in compliance Gulf Coast Supply Rollformer Association's current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.		
	Panels shall be secured along the male rib with approved clips and two corrosion resistant #10 pancake head fasteners of sufficient length to penetrate through the sheathing a minimum of ${}^{3}/{}_{16}$ ". The panel clips were placed at a spacing listed in Table A below starting 3" from panel end. The female rib of panel is installed over the male rib of panel. A bead of Bostik Chemcaulk is placed between the seams for 90° seam only. Panels are seamed as listed below in Table A.


LIMITATIONS

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 6. Panels may be jobsite roll formed with machine model S#8510804, S#10220207, S#2050711, S#2751012, S#9291105, S#3270414 from Gulf Coast Supply Rollformer Association.
