Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4"

side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with the current published installation instructions and details in Gulf Coast Supply &

Manufacturing LLC's Installation Manual.

Metal Panels and Install the "26Ga. GulfRib Roof Panel" and accessories in compliance with Gulf Coast Supply & Manufacturing LLC's current published installation instructions and details.

Supply & Manufacturing LLC's current published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards

RAS 133.

26Ga. GulfRib Roof Panels shall be fastened with a minimum of #9-15 x 1-1/2" woodgrip corrosion resistant screws. Fasteners shall of sufficient length to penetrate through the sheathing a minimum of $^3/_{16}$. Fasteners shall be place in accordance with fastener detail

herein as follows:

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.



DETAIL A




FIELD CONDITION
